- Department of Human Enterprise and Innovation
- Department of Supply Chain and MIS

Reason: The current department of management is spread over a number disparate topic areas. This varied range of topics makes it difficult to generate areas of expertise with focus and direction.

Why is this important: As we move forward as a school there is a need to be relevant to students, the community and ourselves.
