GETTING STARTED

If you have little experience with computers, take a few of our introductory computer courses (COMP 1010-1080) to familiarize yourself with Microsoft application software as there are no computing courses designated in any of the Tourism Management related diplomas.

Communication courses need to be completed as early in your program as possible to best support your success in future course work. Ensure that these courses are in your schedule as soon as possible!

CURRICULUM & REGISTRATION

This document shares the courses required in your diploma and includes a suggested sequence of study to assist your course planning and registration processes. By taking the courses in the order recommended, you will naturally meet all course prerequisites. If you are studying part-time, or starting in a semester other than fall, this sequence will not apply to you, so you will need to carefully consider prerequisites when course planning. Keep in mind that it is your responsibility to ensure that you are meeting your program requirements, so course plan and register with care. Ask questions if you are not sure and do your best in every class so that you have the opportunity to complete the diploma in a two year time frame!

ADVANCE CREDITS & EXEMPTIONS

- Should you meet the requirements to receive an exemption from MATH 1100, you will be required to make up the 3 credits with an elective of your choice http://www.tru.ca/act/tourism/admission.html
- Transfer credits can be granted on course work from other institutions up to a maximum of 30 credits. To

You are able to ladder your completed diploma into the Bachelor of Tourism Management (BTM). To do so, you must apply to the BTM after finishing the diploma. You will receive credit for your diploma courses, beginning the BTM with third year standing. This means it is possible to complete the BTM in as little as two additional years of study. You also get access to other options including Coop and Study Abroad!

Program advising is available to assist you in making informed decisions that will enhance your educational experience. Contact with a program advisor is mandatory for 3rd and 4th year Canadian students and all International students for course plan approvals prior to your registration.
